Welcome to the first newsletter of 2007. By the end of last year our membership had increased to over 500 members which is very good news for us.

The excellent response to last years' questionnaire had enabled us to put all your comments through to the Forestry Office at Santon Downham for them to analyse and incorporate into their future plans and by the end of 2006 the new toilet block was completed at High Lodge, and is a welcome addition to the facilities already in place in this ever-busier location.

However not everyone is interested in a 'busy' forest and it should not be forgotten that High Lodge is only a small part of a very large forest area - There are still plenty of places where the forest is much quieter if you simply want to walk and observe the wildlife in peace and solitude.

Even at High Lodge it is possible to move away from the visitor centre only a few hundred yards and discover the newly renovated wild life hide, which the conservation group was instrumental in reviving and making accessible to all - no longer do you need to climb the steps to enter the hide as a ramp has been put in to enable access for those who less mobile or in a wheelchair.

This was another example of what can be achieved by a small group bringing to the FC's attention a shortcoming in the existing facilities and helping to put it right, so if you have an idea how to improve an existing area or an idea for something new, please let us know so we can pass it on to FC for them to consider in their future plans.

Forest closures will be due to clear felling in the Mundford and Hockwold areas, thinning in the area of Lynford Water (Gravel Pits), and possibly at the Arboretum. Thinning will also be happening at Elveden. Please obey and signs in the areas, they are for your safety.

## The Lynford Arboretum Project

Last year the Forestry Commission approached Friends and asked us to assume the care of Lynford Arboretum. This request raised many eyebrows and even more questions; what was meant by 'care'? What would be involved? Were there any time scales we would be expected to achieve? These were just a few, a very few, of the many questions posed.

Over the autumn and early winter a series of meetings, a site visit and a conservation day were convened and the size of the task became apparent. Firstly, 'Care' does not include the trees themselves or the cutting of the grass; the Commission will continue to undertake these jobs.

Our involvement is needed in the maintenance of the hard path system, which is suitable for persons in wheelchairs, the seats and benches (something Friends are already doing elsewhere in the forest), keeping the grounds free of litter, fortunately not a big problem here, and the shrub beds. These, at first sight, looked formidable, but four hours and eight or nine people on a Sunday morning showed that small inputs of effort on a regular basis can and would bring the arboretum up to a very acceptable standard.

The site has suffered from years of under funding (Not the FC's fault!) and there seems little if any prospect of the situation changing. The Commission made it quite clear that there were no times scales being set, more, if Friends took the task on we would set our own pace.

A simple, joint, management structure is envisaged to guide effort and thought; the effort, on a week-by-week basis and thought about the future. To look to the need for any training requirements; safety and the needs of the volunteers; things you can't work out on the back of an envelope.

But why all this effort you may ask? Simply because it is, in scientific terms, a place of some importance; yes the commission has other arboreta however Lynford is sited on Breckland's thin and impoverished soil, which is interesting in its self, it also contains examples of the Serbian Spruce, sadly rare in its native land and on the UN's list of endangered species. Could not this arboretum continue in much the same way as it is? In scientific terms, yes, however this is a tranquil place which deserves better. It requires care and explanation, the care of its uniqueness and the explanation of its importance.

Coming up to date; early last December 122 members who live within a twenty five minute drive of the arboretum were contacted and invited to express an interest, or otherwise, in the formation of the Lynford Arboretum Group. With Christmas around the corner it probably was not the best time to try and engage people in thinking about this project but it has been heartening in the numbers responding; if you haven't, please do so.

## Foresters Log January 07

Firstly a very Happy New Year to all of you. We had a very successful Christmas season this year. Santa was so, so busy with almost every opportunity to see him taken. I am sure he is now taking that well-earned break. Thank you especially to those members of Friends who helped the Forestry Commission at this event, we are very grateful for the support you provide at these busy weekends.

### **Flushed with success**

Spending a penny at High Lodge should be easier from the Spring – the Forestry Commission have splashed out on its visitors wishing to answer the “call of nature”!

Local builders, Kybird, successfully bid for the contract and at the end of December they handed the building over to the Forestry Commission on time and within budget. This project has been funded by European Union Objective 2 Funding, Breckland District Council and the Forestry Commission.

Work to construct paths and landscape the surrounding areas is currently underway and the new toilet block will be open for use at the start of the new season on 31<sup>st</sup> March 2007.

### **Forest Toll**

Entry to High Lodge is now TOLL FREE until the end of March except for weekends and school holidays, so why not come and enjoy the mild winter we are having and breath the forest air! From April 1<sup>st</sup> Forest Toll for cars will be £6. This increase is due to an administrative change, which means the Forestry Commission is now liable to pay VAT on this charge. If you go for the season ticket ‘joint deal’ you can get a reduction in the cost of the season ticket by also joining Friends.

### **Cycling Around**

We already have in place our new Cycle leaflet, which has been produced with our corporate look and includes the new Red Route. This is 11 miles of mostly single track, less challenging than the Black Route, but for the experienced rider. Recommended for aspiring cyclists over 12 years old. The leaflet is for sale for £1 from High Lodge and the Forest District Office and as before is printed on waterproof ‘paper’

### **Play equipment on picnic sites**

The Forestry Commission has had to accept budget cuts over the last few years, and as a result of this we have had to make cutbacks in some of our facilities. The play equipment at St Helens and at Lynford Stag has unfortunately been removed recently for Health and Safety reasons. The ongoing cost of the safe upkeep of play equipment has made this necessary.
